PENAL NOTICE

ANY OTHER PERSON WHO KNOWS OF THIS ORDER AND DOES ANYTHING WHICH HELPS OR PERMITS THE DEFENDANTS TO BREACH THE TERMS OF THIS ORDER MAY ALSO BE HELD TO BE IN CONTEMPT OF COURT AND MAY BE IMPRISONED OR FINED OR HAVE THEIR ASSETS SEIZED

BY CONSENT

IT IS ORDERED:

1. The First and Defendant and each of them shall not:
  - a. enter any premises owned by or otherwise occupied by the Claimant ("Trust Premises"), being the buildings shown on the map attached to this Order at Schedule 1 and delineated in red except when:
    - i. Specifically invited to do so by an employee of the Claimant of Director level or above;
    - ii. An individual is employed as a security guard at the Trust Premises and such entry is required in order for that individual to perform their duties;
    - iii. The individual is accompanying a worker employed at the Trust Premises for the purpose of section 10 of the Employment Relations Act 1999 and is entitled to so accompany them; or
    - iv. The individual is attending the Trust Premises as a parent or guardian of a patient of the Claimant.
  - b. Block, obstruct or impede access to or from the Trust Premises by any person or vehicle.
  - c. Engage in any of the following within 50 metres of the Trust's Premises:
    - i. The playing of amplified music or music which features the use of percussion or horns;
    - ii. Shouting, the use of megaphones or any other method of voice amplification;
    - iii. Photographing or videoing individuals entering or leaving the Trust's Premises.
  - d. The restrictions in (c) above shall not apply to the designated area marked in blue on the attached map at Schedule 1 located in the vicinity of Zayed Centre for Research Into Rare Disease In Children, 20 Guildford Street, 20 Guildford Street, London, WC1N 3EN ("the Blue Zone").
2. The First and Second Defendant and each of them shall not organise any protest activity within 50 metres of the Trust Premises, save for fixed assemblies at one of the three following locations and direct transit to or from any such locations:
  - a. The area shown marked by a black line on the map at Schedule 1 being the area outside the Paul O'Gorman Building ("the Black Zone");
  - b. the Blue Zone,
  - c. on the pavement on the south side of Great Ormond Street.
3. The First and Second Defendants and each of them shall:

- a. Ensure that any attendance for the purposes of section 220 of the Trade Union and Labour Relations (Consolidation) 1992 Act ("TULRCA") takes place only in the Black Zone;
  - b. Restrict the attendance in the Black Zone to security guards employed by Carlisle Support Services Ltd who work at Trust Premises and any official of the First Defendant who is representing a security guard and whom he or she is accompanying;
  - c. Restrict any attendance in the Black Zone to a maximum of six people (within the description at (b) above); and
  - d. Comply with the requirements of section 220A TULRCA.
4. The First and Second Defendant and each of them shall procure that the First Defendant's officers, officials, and agents shall comply with the Orders set out above at paragraphs 1, 2 and 3.
  5. The First and Second Defendant and each of them shall use best endeavours to ensure that its members and others attending a protest or similar event organised by the First or Second Defendant shall comply with the Orders set out at paragraphs 1, 2 and 3.

#### **Publicity**

6. The First Defendant shall forthwith, and in any event by 5pm on 17 February 2022, publish a copy of this order on their website.
7. The First Defendant shall do forthwith, and in any event by 5pm on 17 February 2022, undertake all reasonable steps to make its officials and members aware of this order, including by distributing a copy of this order to their members by email.

#### **Variation and Discharge of this Order**

8. This Order shall remain in force until 4pm on 1 October 2022, with liberty to apply but if any party wishes to do so they must inform the other party or their legal representative immediately and in any event not less than 48 hours before the hearing of any such application.

#### **The Order of Mrs Justice Cutts**

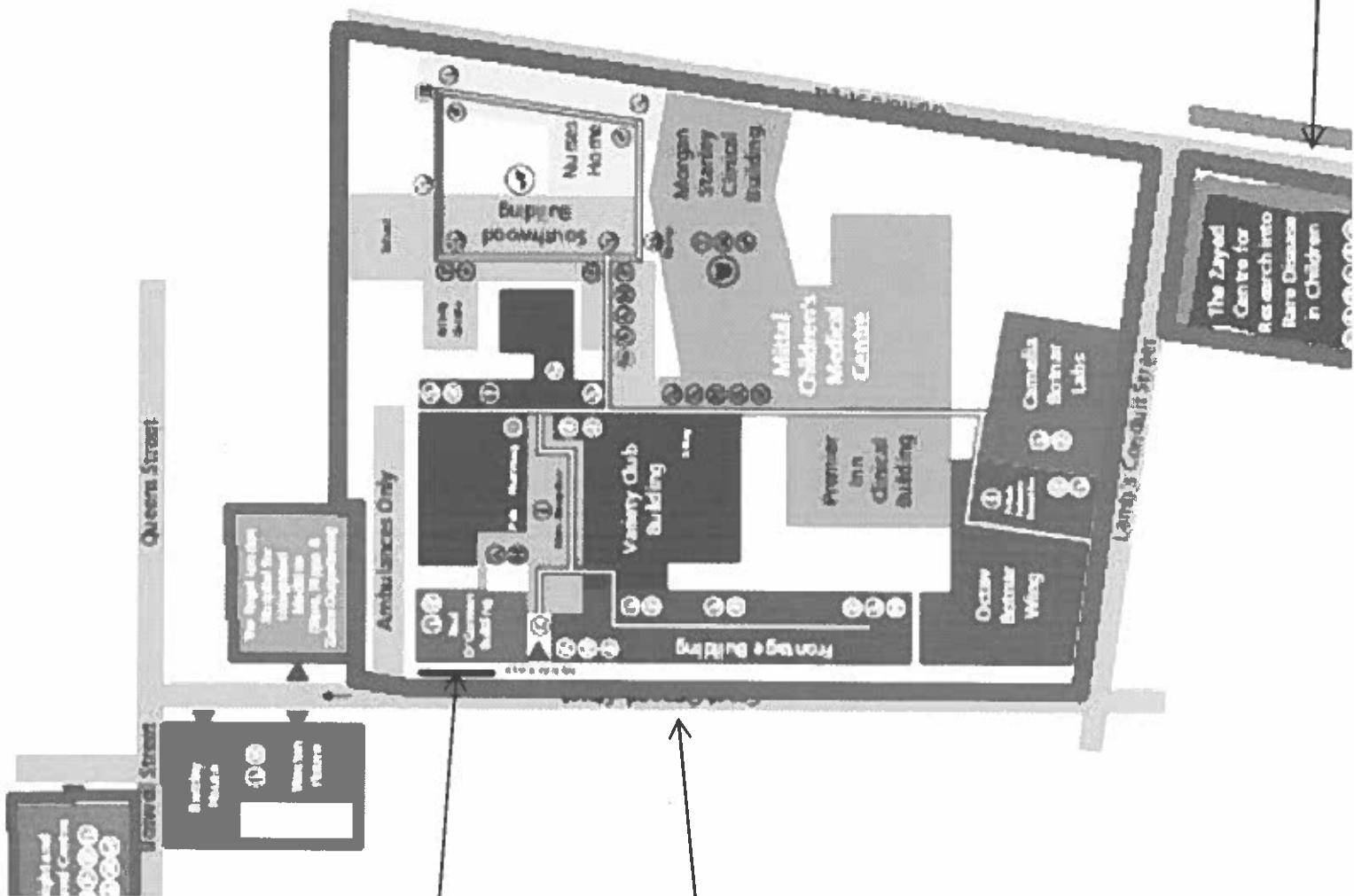
10. The Order of Mrs Justice Cutts, sealed on 11 February 2022, is discharged and no longer applies.
